**TOUR PRICE: \$4,950.00** 

RESERVATIONS & PAYMENTS: Registration Forms and \$\frac{\$300 \text{ non-refundable deposit}}{2018; Second payment of \$2,325.00 is due by May 1, 2018 and Final Payment of \$2,325.00 is DUE IN THE OBED OFFICE NO LATER THAN June 1, 2018.

<u>CANCELLATION POLICY:</u> Cancellation notice must be received in writing and is only valid the date it is received. Notification of cancellation by telephone does not suffice. For cancellations received after June 1, 2018 <u>THERE ARE NO REFUNDS.</u>

NOTE: Some airlines charge 50% and up for any changes or cancellations from the beginning. Many airlines require non-refundable deposits from the beginning. We will make every effort on your behalf to refund what is due you. However, if there are additional air or hotel cancellation charges, or other out-of-pocket expenses, these will be passed on to you.

## ONCE PURCHASED - YOUR TICKETS BECOME NON-REFUNDABLE AND NON-TRANSFERABLE.

**REFUNDS:** Refunds may take at least 90-120 days due to claims to airlines and suppliers for refunds.

HOTELS: Hotels are provided throughout Israel. Price included in tour package is based on double occupancy.

MEALS: Meals in flight per custom of the airline. Full Israeli breakfasts and dinners are included; beverages may or may not be included. Lunches are not included. No credit will be given for unused meals while on tour.

GROUND TRANSPORTATION: All ground transportation in Israel is to be deluxe, air-conditioned motor-coach.

SIGHT-SEEING: This tour includes a full program of sight-seeing in Israel by government-licensed, English-speaking guide. All entrance fees to sites mentioned in itinerary are included.

TRANSFERS: Transfers of tour participants and luggage (see luggage restrictions) between overseas airports, hotels, etc. per itinerary are included.

**LUGGAGE:** Luggage is restricted in size and shape by the airline. The tour participant may contact the airline for specific instructions. The Obed Project cannot be held liable in any way for damage or loss of luggage at any time during the tour. **AIR TRANSPORTATION:** Tour participants will travel by regularly scheduled airline economy class jet service. Price is based on special group airfare with group flying together for entire itinerary.

PASSPORT: Every tour participant must be in possession of a valid passport good for 6 months AFTER our return! Law does not require vaccinations of any kind. No visa is required of U.S. citizens for entry into Israel; others are advised to check with the Israeli Consulate in their area.

**NOT INCLUDED:** Excess luggage charges, single supplement for room (\$1,330.00 if available), passport, insurance, expenses resulting from personal illness or accident, lunches, food or beverage items not included in meals, items of a personal nature such as laundry, telephone call service charges, room service, and all other items not stated as included.

FINAL TRÂVEL DOCUMENTS: Final documents including hotel information, luggage tags, name tags, general information, flight itinerary, and final letter of instruction will be sent after final payment has been received. Expect them no earlier than 7 to 10 days prior to departure.
